



## Valley County Downtown/Periphery Area Improvements *Rebate Program Application*

Valley County Economic Development offers a dollar-for-dollar rebate program (maximum not to exceed \$10,000 per project) for businesses within the business corridor in any of the four Valley County community downtowns. These funds allow for improvements to downtown commercial buildings in any of the four business districts of Ord, Arcadia, Elyria, and North Loup.

**Applications must be submitted, and approved, before work begins.** This is a rolling application cycle and funds will be based on availability at any given point in time, and on a first come, first served basis.

One rebate is allowed per business, per calendar year. Applicants are responsible for paying contractors.

If a situation would arise where damage from any sort of disaster may occur to the project and insurance will cover repairs, the rebate would not apply or be valid as approved, until insurance claims have been finalized. At that time, a committee will review the documentation from repairs and insurance payments to determine what, if any, of the rebate approved is still valid.

- Landscaping and signage
- Building code compliance improvements
- Second story housing
- Building demolition
- Asbestos or other hazardous material removal

- A “before” picture of the project or project area, **or** an in-person tour to view the project.
- A detailed description with cost estimates of the improvements to be made including materials, size, color, etc.

**Application Process:**

---

1. This is a rolling application cycle and funding will be based on availability of funds at any given point in time, and is available on a first come, first served basis. (*One rebate opportunity per business, per year.*)
2. Complete the application along with the required supporting documentation and submit it to the Valley County Economic Development Board for review. The board will have the right to determine the periphery of each of the four communities’ business districts, and whether the project fits within the required parameters.
3. Proceeds will be distributed upon project completion after verification of expenditures.
